(c) If this solicitation is amended, then all terms and conditions which are not modified remain unchanged.

This addendum was issued to answer question.

1) On the "Bid Forms" document or page 24 of the bid invitation, there is a like item called "travel time" (1 hour fee for each truck and 1 hour fee for each man).

This line item does not specify the number of men or trucks to be tabulauted and would be a fluid number based on staffing.

The question is: Can this line be omitted and ignored on the "bid for", page 24?

2) Under Part 1: Moving Services. For Travel Time (1 hour fee for each truck and 1 hour fee for each man), do you want me to just put what we charge for 1 truck/hour + the charge for a driver for 1 hour?

3) In the same section: Materials 14.5 cubic sq ft box. Is this correct, or is that supposed to be cost for a 4.5 cubic sq ft box?

ANSWER: The District uses these 2 box sizes: 18"X12"X12" and 16"X16"X12"calculate your cost on these two box sizes.

4) Under Part 2: Storage. If I put in cost for storage billed by space, is it ok to leave the section that is billed by weight blank?
